Phoenix Drop-In Center

WHAT IS THE PHOENIX DROP-IN CENTER?

The Drop-In Center provides adults with a safe and supportive place for recreation, education, volunteer and peer support opportunities.

The Phoenix Center is open Monday - Friday from 9:30 a.m. to 4:30 p.m. Check the Phoenix Center calendar for evening events.

WHAT SERVICES ARE PROVIDED AT THE DROP-IN CENTER?

We offer a variety of services, such as:

- Creative writing and craft classes, bingo, pool, darts, Wii bowling, picnics at the park, miniature golf, and activities to get members up and moving
- Members can participate in our Smart Shopper program and receive free transportation to Walmart and Aldi's, as well as recipes and shopping tips
- Free lunch is provided to members Monday - Friday at noon
- Members can do their laundry at a minimal cost and receive free transportation on Tuesdays

WHAT GROUPS MEET AT THE DROP-IN CENTER?

Wellness: A weekly group that discusses topics on mental wellness.

Dual Recovery Anonymous: Dual Recovery Anonymous™ is an independent, nonprofessional, Twelve-Step, self-help support group for individuals with dual diagnosis, (co-occurring disorder). The goal is to help individuals who are chemically dependent and are also affected by a mental health challenge.

Ladies Lounge: A monthly group that provides an opportunity for ladies to get together and offer support to each other in a relaxed atmosphere. We end the evening with fun and games.

HOW TO BECOME A DROP-IN CENTER MEMBER

It is easy to become a member of the Phoenix Drop-In Center. Just stop in the Drop-In Center on the first floor of the Mental Health Association and fill out an application. Membership is free to adults living in Beaver County. You must be a current or past recipient of mental health services.
