## **MEMBER RIGHTS**

As a member of Beacon Health Options you have:

- The right to be treated with respect and dignity
- The right to privacy concerning medical records and conversations with people who give you care
- The right to choose providers from a Beacon Health Options provider list
- The right to receive services without regard to race, color, religion, sex, sexual orientation, age or ethnic background
- The right to see your medical records and talk about them with your provider
- The right to make a complaint or file a grievance about your care or the services you receive without any type of punishment
- The right to take part in decisions about your care
- Participating members also have responsibilities, which are also important to know. They are listed in the Beacon Health Options handbook

Consumers of behavioral health and/or substance abuse services through the network of Beacon Health Options. This company organizes services for Health Choices recipients.

The Ombudsman program serves adults, children, teens and their families. The program serves seven counties in Southwestern Pennsylvania: Armstrong, Beaver, Butler, Indiana, Lawrence, Washington and Westmoreland.
